

Synthetic Cannabinoid Withdrawal and Addiction

TO: General Practitioners, Social Workers, Youth Health workers, Community Alcohol and Drug Services.

It is anticipated that patients with mild cannabinoid withdrawal can be managed at home with GP supervision.

Patient care should be coordinated by a GP in collaboration with Alcohol and Drug services in the community.

The most common features of withdrawal are: agitation, insomnia, anorexia, nausea, tremor, sweating, vomiting and haematemesis. May last hours to several days.

Significant withdrawal features: violence, psychosis, dehydration, renal impairment.

For patients presenting with associated suicidal ideation, symptoms suggestive of a significant mood or psychotic illness, a referral to a the Psychiatric Emergency Service is advised.

Emergency Department can assist with significantly unwell patients but do not offer a detox service.

Medications that may be of assistance for symptom management of withdrawal.

For Agitation/Irritability:

Quetiapine 25-50mg, Max 200mg/24 hours. Example starting dose 25mg bd, 25-50mg at night.

For Diarrhoea

Loperamide 2mg, 1-2 capsules, maximum 8 caps/24hours

For nausea/vomiting

Metoclopramide 10mg tds, Max 30mg/24hours

For Headaches/Muscle cramps

Paracetamol 1-2 tabs max 4gm/24hours.

For GI Cramps/Spasms

Hyoscine Butylbromide (Buscopan) 10-20mg 4-6 hourly

For Sedation

Promethazine 25-50mg nocte Max 50mg at night

OR

Quetiapine 50mg nocte

Detox

It is anticipated that patients with mild withdrawals can be managed at home with GP supervision.

Dependence with moderate to severe withdrawal may require formal detox.

The Home detox service and Thorpe social detox are both managed through the City Mission.

Kennedy Residential detox can ONLY be arranged if a patient has undergone a comprehensive AOD assessment which has determined that a formal medical detox is required.
