# Guidance for use of Personal Protection Equipment (PPE) for community-based midwives

Nationwide there is increased demand for PPE as a result of COVID-19.

Our priority is to ensure we have sufficient stocks available for frontline health workers to ensure staff and patient safety in our hospitals, aged residential care facilities, general practices, and in the community.

Like all health professionals, midwives will face some challenging scenarios.

We know you will continue to put the care of the women/wāhine and their pēpē first. We want to ensure that we do all we can to assist you to also prioritise your own health.

The provision and use of Personal Protection Equipment (PPE) is a key element to keeping you and your mothers and their babies safe.

The Ministry of Health has developed a national framework to enable all DHBs to prioritise PPE to those who need it, and to guide the effective use of PPE.

Community-based organisations not usually provided with PPE by District Health Boards, ARE included in the Ministry of Health framework in relation to COVID-19. All health care providers will be provided with PPE for use as required and in accordance with Ministry of Health guidelines. **This includes midwives**.

#### When is PPE required?

It is important we first understand when PPE is required. The Ministry of Health's criteria for prioritisation includes:

• Risk of being exposed to someone who has or potentially has COVID-19

- Length of exposure more than 15 minutes at a distance less than 1 metre
- Type of exposure, for example, delivering close care to a confirmed or suspected COVID-19 case

## Midwives and personal protection equipment (PPE)

Your health and the health of women and babies in your care are the priority. As Lead Maternity Carers (LMC) you will have a number of women you are caring for. It is important that you do not expose other women in your care. The objective must be to protect all women and babies as well as yourself.

The New Zealand College of Midwives (Canterbury/ West Coast Region) and the Canterbury District Health Board (CDHB) have agreed a process to manage the provision of PPE to community-based midwives.

COVID-19 has been found to transmit to babies post-partum but generally does not appear to cause severe disease as it does in adults, including pregnant women.

### Where do I get the PPE from?

Midwives will be issued with PPE to have on hand in their vehicles.
